#### **Weed & Pest Department Monthly Update**

Everything is closed up at the shop and all equipment has been winterized. Mike Rohrbach and Jerry Lehrkamp are both at the Highway Shop and Chris Hemen is back at the State's Attorney's Office. We had a very productive last two months at the shop and were able to spray all the townships that signed up, all of our private spray accounts, and all of the county ROW. We were also able to do a fall pre-emerge spray for bridges and rip-rap, so that should give us a little bit of a head start for 2026. Hemen has completed and submitted the Inspection Summary required by the state. Next month, he will complete the required fiscal report and Supervisor's report due by the end of January.

Chris Hemen applied for the FY2027 contractual grant and also applied for a \$1,000 competitive grant to continue mapping and spraying toadflax.

#### **Noxious Weed Request**

Any new requests and renewals for locally noxious weeds need to be submitted to the South Dakota Weed & Pest Control Commission by January 23<sup>rd</sup>. Brown County doesn't have any that are expiring this year. Hemen mentioned to the Board that we may want to consider adding common mullein to the list sometime in the near future as it has been spotted on the Brown/Edmunds County border. After some discussion, it was decided to not add it to the list this year, but perhaps next year.

Tyler Stadel said he didn't have any updates from NRCS.
